Concerning the Amendment and Extension of the City-Wide Urban Revitalization Tax Exemption District Plan (URTED)

RESOLUTION NO. 2015-59, AMEND AND RENEW CITY WIDE URTED PLAN:

Cangas MOVED and Seidel SECONDED to adopt a resolution amending the City-Wide Urban Renewal Tax Exemption District Plan (URTED) so commercial, residential and multi-residential improvements would be eligible for tax abatement and extending the time frame until October 13, 2018.

David Varley, City Manager, reported this program gives property owners a 100% property tax exemption for three years for improvements to their property. Residential improvements must increase the property value by 10% and commercial by 15%.
